Trackers Earth Medication Policy

Campers that need to take medication during the day or have available medication available in case needed must:

- 1. Bring the medication in original packaging (with Camper name marked).
- 2. Attach specific written instructions regarding dosage and usage of the medication from a parent (for non-prescription medication) or a licensed provider (for prescription medication).
- 3. Disclose the medication upon check in.

Campers must be able to **self-administer** and **self-remind** regarding medication. Trackers Guides are not trained in medication administration. Every camper must be able to identify when medication is needed and self-administer their own medication. This means that if medication is needed (or needs to be taken a certain time), the camper must ask the Guide for the medication and be able to manage their own dosage and administration.

The Guides may *help* to provide a medication reminder to the camper. For Overnight Camps and Base Camps, reminders for routine medication can generally be provided. However, our Day Camps are unique in that they are field-based and adventure-focused. Given the unpredictable nature of these camps and dynamic Guide responsibilities, the Day Camper should not expect a consistent reminder.

In both settings, if there would be health consequences if medication were delayed or missed, please consider whether Trackers camps are a good fit. We need to be clear about the limitations of medication administration at our camps. We want your camper to be healthy and safe.

Medication Storage per programs:

For Overnight Only: All medication will be stored in a locked unit or in Guide's pack during day activities. For all campers, please fill out the and complete the [LINK FORM: Health History Form] BEFORE program start.

For Day Camps: The Camper will generally carry their medication with them in their own pack. If the medication includes controlled substances, or there is otherwise a need for the Guide to carry the medication, please indicate on **the Medication Release form (below).**

Please Note: EpiPens or rescue medicine (inhalers, etc.) always remain with the camper in their own pack.

Please discuss any concerns with the Camp Director.

Trackers Earth cannot guarantee that the medication will be safe from the elements. The medication may be lost, destroyed, or damaged throughout the camp's adventures. Please plan accordingly.

EpiPens or rescue medicine (inhalers, etc.) always remain with the camper in their own pack.
